AS TREASURER OF THE SCHOOL, WE OVERSEE ALL ASPECTS OF HOW MONEY IS SPENT. THIS INCLUDES BUYING FRESH FRUITS AND VEGETABLES FOR SCHOOL LUNCHES, PURCHASING MEAT AND PAYING A COOK TO PROVIDE THE CHILDREN A HOT LUNCH. WE TAKE A PARTICULAR INTEREST IN THE CHILDRENS' DIET AS OBESITY IS A GROWING PROBLEM IN JAMAICA AS A RESULT OF AN ABUNDANCE OF PACKAGED FOOD.
